AN ORDINANCE ANNEXING CERTAIN TERRITORY TO
THE CITY OF URBANA, ILLINOIS

WHEREAS, it is provided in Article 7-11 of the Cities and Villages Act of the State of Illinois that whenever any unincorporated territory containing sixty (60) acres or less, is wholly bounded by a municipality, such territory may then be annexed to said municipality by the passage of an ordinance to that effect, and

WHEREAS, the hereinafter described territory is wholly bounded by the City of Urbana, a municipality located in the County of Champaign and State of Illinois.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:


1. That the following described territory, to-wit:

Commencing at the center of the intersection of Cunningham Avenue (U. S. Route 45) and Barr Avenue on the South line of the Northeast Quarter of Section Eight (8) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian in Champaign County, Illinois, thence West along the South line of the Northeast Quarter of said Section Eight (8) to the East line of the Champaign County Housing Authority Land, thence North along the East line of said Housing Authority Land to the Northeast corner thereof, thence West along the North boundary of said Housing Authority Land to a point directly South of the East line of Division Street, thence North to the center line of Kerr Avenue, thence East along the center line of Kerr Avenue One Hundred Ten feet (110') to a point Twenty feet (20') South of the Southeast corner of Lot Eleven (11) of Orville J. Hewkin's Subdivision, thence North along the East line of Orville J. Hewkin's Subdivision to the South line of Lot Thirteen (13) of a subdivision of the Northeast Quarter of Section Eight (8) Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, thence East along the South lines of Lots Fourteen (14) Fifteen (15) and Sixteen (16) of said subdivision to the center line of Cunningham Avenue (U. S. Route 45), thence in a Southwesterly direction along the center line of Cunningham Avenue (U. S. Route 45) to a point directly East of the North line of Lot Four (4) of J. T. Kaucher's Addition, thence West to the Northwest corner of said Lot Four (4) of J. T. Kaucher's Addition, thence South to a point Seventy-six feet (76') South of the center line of Kerr Avenue, thence East to the center line of Cunningham Avenue, thence South along the center line of Cunningham Avenue to the point of beginning, all situated in the County of Champaign and State of Illinois,

being wholly surrounded by the City of Urbana, a municipal corporation, organized and existing under the laws of the State of Illinois, is hereby

annexed to said City of Urbana.
