AN ORDINANCE LEVYING A TAX FOR STPEET AND BRIDGE PURPOSES IN THE TOWN OF CUNNINGHAM, CHAMPAIGN COUNTY, ILLINOIS FOR THE YEAR BEGINNING MAY 1, 1958, AND ENDING APRIL 30, 1959

WHEREAS, the City of Urbana, Illinois, includes wholly within its corporate limits, the Town of Cunningham and, therefore, comes within the provisions of Section 69-6 of Chapter 24 of the Revised Statutes of the State of Illinois, for the levying of a street and bridge tax.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That there be and is hereby levied upon all taxable property within the Township of Cunningham, Champaign County, Illinois, lying wholly within the corporate limits of the City of Urbana, Illinois, for street and bridge purposes in the Town of Cunningham, Champaign County, Illinois, the sum of \$24,000.00, pursuant to the provisions of Section 69-6, of Chapter 24 of the Revised Statutes of the State of Illinois.

SECTION 2. That, whereas, three-fourths of the members elected to the City Council of the City of Urbana, are of the opinion that a greaterlevy for bridge and street purposes is needed, there is hereby levied an additional sum for street and bridge purposes in the amount of \$11,000.00, pursuant to the provisions of Section 69-6 of Chapter 24 of the Revised Statutes of the State of Illinois.

That this levy totalling \$35,000.00, be and is in addition to all other tax to be levied by the City of Urbana for general corporate purposes as provided in Section 16-1 of Chapter 24 of the Revised Statutes of the State of Illinois, and in addition to (1) any tax that said City is now authorized to levy for street and bridge purposes, and in addition to (2) any tax that said City is now authorized to levy on all property within the City, and shall be expended as follows:
