ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF URBANA, ILLINOIS FOR STREET AND BRIDGE PURPOSES IN THE TOWN OF CUNNINGHAM, CHAMPAIGN COUNTY, ILLINOIS.

FOR THE YEAR BEGINNING MAY 1, 1960 AND ENDING APRIL 30, 1961. WHEREAS, the City of Urbana, Illinois, includes wholly within its corporate limits the Town of Cunningham, and, therefore, comes within the provisions of Section 69-6 of Chapter 24 of the Revised Statutes of the State of Illinois, for the levying of a street and bridge tax.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION 1. That for the fiscal year commencing Mayl, 1960 and ending April 30, 1961, there be and is hereby appropriated for street and bridge purposes in the Town of Cunningham, Champaign County, Illinois, the sum of \$24,000.00, pursuant to the provisions of Section 69-6 of Chapter 24 of the Revised Statutes of the State of Illinois.

SECTION 2. That, whereas, three-fourths of the members elected to the City Council of the City of Urbana, are of the opinion that a greater appropriation for street and bridge purposes is needed, there is hereby appropriated for said fiscal year, an additional sum for street and bridge purposes in the amount of \$16,000.00, pursuant to the provisions of Section 69-6 of Chapter 24 of the Revised Statutes of the State of Illinois.

That the total appropriation of \$40,000.00 be and is in addition to all other funds appropriated by the City of Urbana for general corporate purposes and provided in Section 15-1 of Chapter 24 of the Revised Statutes of the State of Illinois, and shall be expended as follows:

Street signs	\$2,000.00
Painting light standards, curbings and street signs	3,000.00
Removing snow from streets	4,000.00
Cutting weeds in streets and alleys	
Trimming trees in streets	
Repairing and relaying sidewalks	6,000.00
Material for street repairs	8,000.00
Tree Removal	8,000.00
Repairing sewers and manholes	

SECTION 3. That this ordinance shall take effect and be in force ten days after its passage, approval and publication as required by law.
