

AN ORDINANCE ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA, ILLINOIS

WHEREAS, it appears to the City Council of the City of Urbana, Illinois, that a petition was filed by the Board of Education of School District No. 116, with the City Clerk of the City of Urbana, Illinois, on the 24th day of July, AD.D, 1963, requesting the annexation of the territory hereinafter described, and owned by said School District No. 116, and said real estate is situated in unincorporated territory adjacent to said municipality, which said petition was accompanied by a correct copy of a resolution duly adopted by the Board of Education of said school district No. 116, recommending such annexation of said school district territory to the municipality of the City of Urbana, Illinois, and there being no electors residing in said territory, and,

WHEREAS, at least two-thirds of the aldermen are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois, that said territory be annexed to and made a part of the City Limits of said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

SECTION I. That the territory described as follows to-wit:

The North 18.110 acres of the Northeast Quarter of the Northeast Quarter of Section Twenty-one (21), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, situated in Champaign County, Illinois, lying South and West of the Right-of-Way of the Wabash Railway Company; and,

The North 16½ feet of the Northwest Quarter of the Northeast Quarter of Section Twenty-one (21), Township Nineteen (19) North, Range Nine (9) East of the Third Principal Meridian, situated in Champaign County, Illinois;

be, and the same is hereby annexed to, and shall hereafter be a part of the City of Urbana, Illinois, and that the corporate limits of said City be, and the same shall be changed so as to include said territory within the corporate limits of said City.

SECTION II. The City Clerk of the City of Urbana, Illinois, shall record with the Recorder of Deeds of the County of Champaign, Illinois, a copy of this ordinance, together with an accurate map of the annexed territory.


