## ORDINANCE OF THE CITY OF URBANA, ILLINOIS VACATING AND RELEASING STORM DRAINAGE EASEMENT

WHEREAS, by a resolution of the City Council duly made and adopted at a regular meeting of the Mayor and Council of the City of Urbana on December 16, 1968, the City of Urbana, Illinois, on the Petition of Raymond Timpone and Alma Maxine Timpone, elected to vacate, abandon and release a storm drainage easement held by the City of Urbana, with reference to property known and described as:

Lot Two (2) of Henry I. Green Estate Addition to the City of Urbana,

and more specifically over and upon the East Sixty (60) feet of said Lot Two (2); and

WHEREAS, it is appropriate that an ordinance be adopted in confirmation of said resolution, for the abandonment and release of said storm drainage easement in order that title to the premises may be perfected;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Urbana, Illinois:

That the drainage easement heretofore reserved to the City of Urbana, Illinois, over the premises described as:

The East Sixty (60) feet of Lot Two (2) of Henry I. Green Estate Addition to the City of Urbana as per Plat recorded in Plat Book "L" at page 8, in the recorder's office of Champaign County, Illinois,

be forever vacated, released and terminated: said easement being reserved in the grant of said Lot Two by deed dated July 30, 1962 and recorded in Book 738 at page 12 in the records in the office of the Recorder of Champaign County and described as follows:

The East Sixty (60) feet of Lot Two (2) of Henry I. Green Estate Addition to the City of Urbana, Illinois.

That said easement is no longer necessary or useful to the City of Urbana, Illinois, and the public interest will be subserved by vacating

and releasing said easement; said easement having been rendered obsolete by the abandonment of the drainage basin construction in connection with the Southeast Storm Relief Project No. 257-80CS in the City of Urbana, Illinois.
