ORDINANCE REGARDING LICENSE EXTENSIONS

WHEREAS, The City of Urbana is in the process of exploring a revision of its Ordinances pertaining to licensing and permits; and

WHEREAS, the City of Urbana has heretofore changed its fiscal year from May 1/April 30 to July 1/June 30; and

WHEREAS, the City of Urbana is a Home Rule Unit as defined in Article VII, Section 6 of the Constitution of the State of Illinois, 1970:

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, that:

Section 1. All licenses and permits heretofore issued by the City of Urbana during the present fiscal year which would otherwise expire on April 30, 1975, may be extended to June 30, 1975 under the provisions of this Ordinance and as hereafter set forth.

Section 2. Applications for new licenses may be accepted, and licenses issued pursuant thereto issued under the terms of this Ordinance.

Section 3. Any license or permit heretofore issued by the City of Urbana which would otherwise expire on April 30, 1975 shall be extended to June 30, 1975, upon request of the license holder to so extend the license and by payment of 1/6 of the present annual license fee therefore to the City of Urbana; provided, however, if the annual license fee is not in excess of \$50.00, the payment due for such extension of said license may be paid to the City of Urbana when the said licensee next applies for a City license or permit.

Section 4. Any person applying for a new license or permit from the City of Urbana may be issued such, to expire June 30, 1975, upon the payment of 1/6 of the annual license or permit fee.

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.
