Lots 1 through 27 in University Downs Tenth Subdivision, as per plat recorded in Plat Book Y, Page 15, in Champaign County, Illinois,

commonly known as University Downs Tenth Subdivision, Urbana, Illinois, and also

All the dedicated street right-of-way within the above platted subdivision

be and the same is hereby annexed to the City of Urbana, Illinois.



Section 3. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.





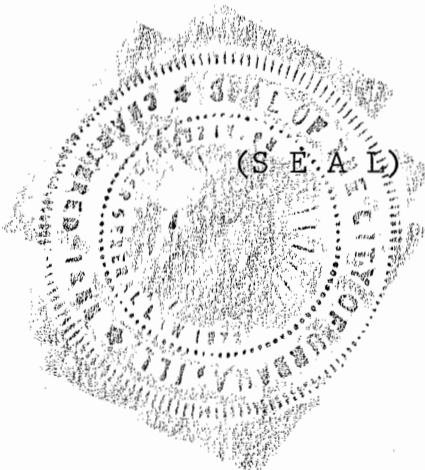
