AN AMENDMENT TO THE ZONING ORDINANCE

WHEREAS, after due publication, a public hearing was held on June 6, 1985, concerning a proposed amendment to the text of the Zoning Ordinance of the City of Urbana, Illinois, in Plan Case #1205-T-85, and

WHEREAS, the Urbana Plan Commission has recommended the adoption of the following changes to the text of the Zoning Ordinance of the City of Urbana, Illinois,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, that:

Section 1. Article XI, Section XI-8, entitled "Fees" is hereby repealed upon the effective date of this Ordinance.

Section 2. The following is enacted in place of the above:

"Section XI-8 Fees

The schedule of fees for various actions taken under the provisions of this Ordinance shall be as found in Chapter 14 of the Urbana City Code, as may be amended from time to time by the Urbana City Council."

This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the Members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council on the 17th day of June, 1985.
