ORDINANCE NO. 9192-83

## AN ORDINANCE AMENDING CHAPTER FOURTEEN OF THE CODE OF ORDINANCES, CITY OF URBANA, ILLINOIS REVISING FEES FOR LIQUOR LICENSES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the subsection of Section 14-7 of Chapter 14, "Licenses and Permits", of the Code of Ordinances, City of Urbana, Illinois, setting the license fee for liquor licenses [(A)General Alcoholic Liquors] is hereby amended to read as follows:

- (9) Class E: A prorated daily fee calculated on a three hundred sixty (360) day yearly basis and based upon the fee otherwise herein established for the type of license that most appropriately corresponds to the type and nature of the retail sale of liquor proposed to be undertaken, but in no event shall such fee for a Class E license be less than forty dollars (\$40.00)
- (10) Special one day, eight-hour . . . . . . \$42.00
- (11) Adjacent premises license, one-half the fee established for the appropriate class of license issued for the principal premises.

<u>Section 2.</u> All ordinances, resolutions or motions or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall be in full force and effect on July 1, 1992 and the City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities and in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a special meeting of said Council.
