ORDINANCE NO. 9596-24

AN ORDINANCE AMENDING CHAPTER 16, ARTICLE I, ENTITLED "NOISE AND VIBRATIONS" OF THE URBANA CITY CODE

BE IT ORDAINED BY THE URBANA CITY COUNCIL that the following sections of the Urbana City Code are amended as provided for herein:

<u>Section 1.</u> The following words appearing in the first sentence of Section 16-2 are repealed:

"If a warning in substantially the manner required in Section 16-3 below is first provided, then"

and capitalize the "i" in the word it which follows.

Section 2. The existing 16-3 entitled "Required Warning" is repealed in its entirety.

Section 3. The following language which was designated "16-2" in the Urbana City Code prior to the adoption of Ordinance No. 9394-24 is hereby repealed:

"No person owning or in possession or control of any building or premises shall use the same, permit the use of the same, or rent the same to be used for any business or employment or residential use, or for any purpose of pleasure or recreation, if such use shall, by its boisterous nature, disturb or destroy the peace of the neighborhood in which such building or premises is situated, or be dangerous or detrimental to health."

Section 4. The Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, at a regular meeting of said Council.
