ORDINANCE NO. 9697-84

AN AMENDMENT TO THE COMPREHENSIVE PLAN OF THE CITY OF URBANA, ILLINOIS

(Rosewood Subdivision Development)

WHEREAS, after due publication, a public hearing was held by the Urbana Plan Commission on February 6, 1997 concerning the Petition filed by Zoning Administrator in Plan Case #1644-CP-97, to amend the City of Urbana's Comprehensive Plan; and

WHEREAS, the Urbana Plan Commission has forwarded the case to the Urbana City Council with a recommendation to approve the request so that the property herein described below and commonly known as the Rosewood Development will be designated Residential and Commercial as indicated on the attached map; and,

WHEREAS, the requested Comprehensive Plan Amendment conforms to the goals and objectives of the City of Urbana's Comprehensive Plan, as amended; and

WHEREAS, the Urbana City Council has determined it is in the best interests of the citizens of the City of Urbana to amend the Comprehensive Plan.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, THAT:

Section 1. The petitioner's request to designate the following described area commonly known as the Rosewood Subdivision Development as illustrated on the attached map is hereby approved:

GREEN FARM PI 30-21-22-400-006

The west ½ of the southeast 1/4 and the east ½ of the southwest 1/4 of Section 22, Township 19 North, Range 9, east of the Third Principal Meridian, situated in Champaign County, Illinois.

NOEL FARM PI 30-21-22-400-004

The east ½ of the southeast 1/4 of Section 22, Township 19 North, Range 9, east of the Third Principal Meridian, situated in Champaign County, Illinois, except that part of the land conveyed to the State of Illinois by Documents 86R857 and 86R858, and except that part of the southeast 1/4 of the southeast 1/4 of Section 22 lying south of the abandoned Norfolk and Western Railroad.
