AN AGREEMENT TO SHARE COSTS OF IMPROVEMENTS TO A CERTAIN ALLEY

This agreement, entered into this <u>5</u> day of <u>August</u>, A.D. 19 <u>98</u>, by and between the CITY OF URBANA (hereinafter called "CITY"), and CARLE FOUNDATION HOSPITAL (hereinafter called "CARLE"), and ST. PATRICK'S CHURCH (hereinafter called "CHURCH").

WHEREAS, the parties have reached an oral agreement to jointly finance the improvements described below to a certain alley located between Main Street and Clark Street and running east and west between Busey Avenue and Coler Avenue; and

WHEREAS, the improvements contemplated herein shall benefit not only the parishioners of CHURCH and the employees of CARLE, but shall also benefit the residents of CITY; and

WHEREAS, the parties desire to reduce their agreement to writing.

NOW THEREFORE, FOR AND IN CONSIDERATION OF THE MUTUAL PROMISES HEREIN, the parties agree as follows:

1. The improvements which shall be undertaken and which are encompassed by this agreement are generally described as:

The installation of storm inlets, construction of a new alley pavement by excavating the existing material and installing a 4" aggregate base and 4" bituminous surface and performing all other work necessary to complete this improvement in accordance with approved plans and specifications.

- 2. Total cost of the improvement, excluding services provided by the City, is estimated to be approximately \$22,500.00.
- 3. The parties agree to share the final cost, excluding services provided by CITY, in three equal shares, provided however, the contribution of CARLE and CHURCH shall not exceed \$7,500.00 each. Any costs incurred over and above the \$22,500.00 figure shall be borne solely by CITY.
 - 4. The services that CITY anticipates donating to the project are:

The making of any surveys needed, obtaining all necessary rights-of-way, obtaining all necessary permits, prepare plans and specifications, solicit bids and award the contract, furnish engineering inspection during construction and cause the improvement to be built in accordance with the plans and specifications and contract.

5. CARLE and CHURCH shall pay to CITY the amount due from each of them hereunder, within thirty (30) days of being billed by CITY for such, after the final costs are determined.

6. The persons signing this Agreement on behalf of St. Patrick's Church and Carle Foundation Hospital represent that they have the full legal authority to bind the entity for which they are signing this Agreement.
