

**AN ORDINANCE APPROVING A SUPPORTIVE HOUSING PROGRAM SUBRECIPIENT  
AGREEMENT WITH CENTER FOR WOMEN IN TRANSITION**

(FY 2007-08)

WHEREAS, on May 5, 2006, the City executed a SHP Grant Agreement with HUD to govern expenditure of SHP renewal funds by the City and the Participating Organizations.

WHEREAS, on February 28, 2007, HUD notified the City that HUD had approved the City's application for SHP funds; and

WHEREAS, on May 5, 2006, the City executed a SHP Grant Agreement with HUD to govern expenditure of SHP renewal funds by the City and the Participating Organizations.

WHEREAS, the Participating Organizations have heretofore expressed their intent to assume responsibility from the City for their respective transitional housing programs with SHP funds and in accordance with SHP regulations; and

WHEREAS, in its application for SHP funds the City declared its intent to provide SHP funds to the Participating Organizations for their use in continuing their respective transitional housing programs for homeless families; and

WHEREAS, on June 9, 2005, the City submitted an application to the U.S. Department of Housing and Urban Development (hereinafter "HUD") for Supportive Housing Program funds (hereinafter "SHP") to continue transitional housing programs sponsored by three private non-profit organizations: A Woman's Place, Urbana, Illinois; The Center for Women in Transition, Champaign, Illinois; and The Salvation Army, Champaign, Illinois

(hereinafter collectively referred to as the "Participating Organizations");  
and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF  
URBANA, ILLINOIS, as follows:

Section 1. That an Agreement providing \$103,917.00 in Supportive  
Housing Program Grant funds to Center for Women in Transition, so as to  
continue their respective transitional housing programs for homeless  
families, in the form of the copy of said Agreement attached hereto and hereby  
incorporated by reference, be and the same is hereby authorized and  
approved.

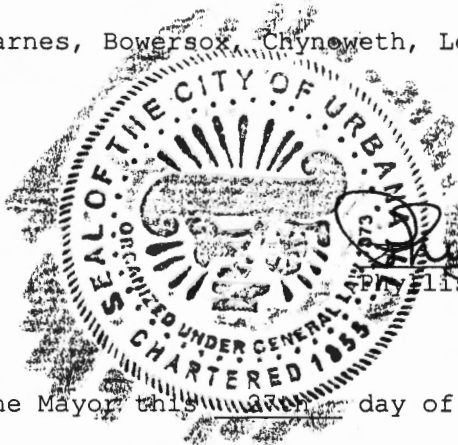
Section 2. That the Mayor of the City of Urbana, Illinois, be and the
