

**AN ORDINANCE AMENDING URBANA CITY CODE
CHAPTER FOURTEEN, SECTION 14-7, REGARDING SCHEDULE OF FEES
SUBSECTIONS B THROUGH P - "LICENSES AND PERMITS," EXCLUDING LIQUOR**

(July 1, 2013 through June 30, 2014)

WHEREAS, the Schedule of Fees herein adopted, having been on file with the City Clerk for at least thirty (30) days prior to this date, and having been made available to the public and mailed to each Council member and having given notice of the availability of the proposed Schedule of Fees for inspection by publication of a notice of such in a newspaper of general circulation in the City at least fourteen (14) days prior to this date.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. Urbana City Code Chapter 14, "Licenses and Permits," Section 14-7, "Schedule of fees," subsections (B) through (P), are hereby amended and as amended shall read as set forth in the Schedule which is attached hereto and incorporated herein by reference.

Section 2. This ordinance will take effect on July 1, 2013.

Section 3. Those sections, paragraphs, and provisions of the Urbana City Code that are not expressly amended or repealed by this Ordinance are hereby re-enacted, and it is expressly declared to be the intention of this Ordinance not to repeal or amend any portions of the Urbana City Code other than those expressly set forth as amended or repealed in this Ordinance. The invalidity of any section or provision of this Ordinance hereby passed and approved shall not invalidate other sections or provisions thereof.

Section 4. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the

effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 5. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage.

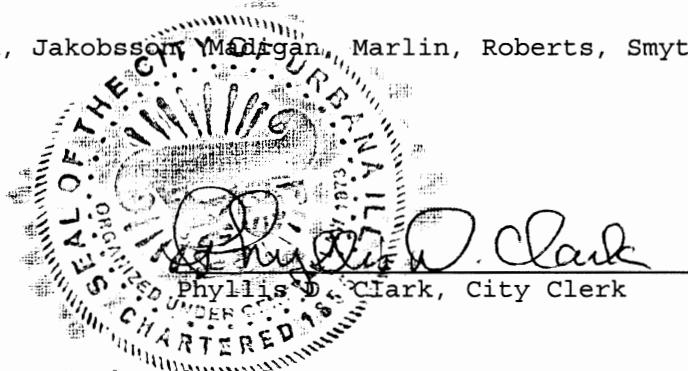
