ORDINANCE NO. 2024-06-021

AN ORDINANCE AMENDING THE URBANA ZONING MAP

(A 2,625-square-foot strip of land adjacent to 710 Cunningham Avenue / Plan Case No. 2490-M-24)

WHEREAS, the City of Urbana ("City") is a home rule unit of local government pursuant to Article VII, Section 6, of the Illinois Constitution, 1970, and may exercise any power and perform any function pertaining to its government and affairs, and the passage of this Ordinance constitutes an exercise of the City's home rule powers and functions as granted in the Illinois Constitution, 1970; and

WHEREAS, Mark Allen requests a rezoning from the AG (Agriculture) zoning district to the B-3 (General Business) zoning district, for a 15-foot by 175-foot strip of land adjacent to 710 Cunningham Avenue; and

WHEREAS, after due publication, the Urbana Plan Commission held a public hearing on June 6, 2024, and voted with eight (8) ayes and zero (0) nays to forward Plan Case 2490-M-24 to the Urbana City Council with a recommendation to approve a rezoning to the B-3 (General Business) zoning district; and

WHEREAS, the City Council finds that the requested rezoning is consistent with the criteria contained in *La Salle National Bank v. County of Cook*, 12 Ill. 2d 40, 145 N.E.2d 65 (Ill. 1957) and *Sinclair Pipe Line Co. v. Village of Richton Park*, 19 Ill.2d 370 (1960); and

WHEREAS, the City Council, after due consideration, finds that an amendment to the Urbana Zoning Map as herein provided is in the best interests of the residents of the City and is desirable for the welfare of the City's government and affairs.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of

Urbana, Illinois, as follows:

Section 1.

The Official Zoning Map of Urbana, Illinois, is herewith and hereby amended to change the zoning

classification from the AG (Agriculture) zoning district to the B-3 (General Business) zoning district,

for the property more particularly described as follows:

A part of the southeast quarter of Section 8, Township 19 North, Range 9 East

of the Third Principal Meridian, City of Urbana, Champaign County, Illinois,

being more particularly described as follows:

Beginning at an iron rebar survey monument found at the southeast corner of

Lot 2 of John Wright's Subdivision as per Final plat recorded as document

number 88R06962 on file in the Office of the Champaign County Recorder;

thence south 00 degrees 50 minutes 04 seconds east along the southerly

extension of the east line of said Lot 2, a distance of 15.00 feet to an iron pipe

survey monument set; thence south 89 degrees 17 minutes 02 seconds west, a

distance of 170.16 feet to an iron pipe survey monument set; thence north 00

degrees 45 minutes 02 seconds west, a distance of 15.00 feet to an iron pipe

survey monument set on the south line of said Lot 2; thence north 89 degrees

17 minutes 02 seconds east along the south line of Lot 2, a distance of 170.14

feet to the point of beginning, encompassing an area of 0.06 acres, more or

less, all situated in Champaign County, Illinois.

with the Champaign County Office of Recorder of Deeds. The City Clerk is directed to publish this


Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in
