


A RESOLUTION  
APPROVING AND AUTHORIZING THE EXECUTION  
OF AN AGREEMENT CONCERNING USE  
OF CERTAIN CITY OF URBANA RIGHT-OF-WAY

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA,

Section 1. That an "Agreement Between the City of Urbana and the University of Illinois Concerning Use of Certain City of Urbana Right-of-Way", a copy of which said Agreement is attached hereto and incorporated herein by reference, be and the same is hereby approved.

Section 2. That the Mayor of the City of Urbana, Illinois, be and the same is hereby authorized to execute said Agreement for and on behalf of the City of Urbana, Illinois.

AGREEMENT BETWEEN THE CITY OF URBANA  
AND THE UNIVERSITY OF ILLINOIS CONCERNING USE  
OF CERTAIN CITY OF URBANA RIGHT-OF-WAY

THIS AGREEMENT made and entered into this \_\_\_\_\_ day of August, 1979 A.D., between the CITY OF URBANA, hereinafter called "CITY," and THE BOARD OF TRUSTEES OF THE UNIVERSITY OF ILLINOIS, hereinafter called "UNIVERSITY," concerning UNIVERSITY use of certain CITY right-of-way, described below.

WHEREAS, UNIVERSITY requests the CITY grant permission to the UNIVERSITY for temporary use of certain CITY right-of-way, as described in attached Exhibit A, which is included as part of this Agreement, for the specific purpose of locating cables where and as shown and designated in Exhibit A until such time as UNIVERSITY use is completed; and

WHEREAS, Article VII, Section 10 of the Constitution of Illinois and the Illinois Governmental Cooperation Act enable the parties hereto to enter into agreements among themselves and provide authority for intergovernmental cooperation.

NOW THEREFORE:

1. CITY, hereby grants permission to UNIVERSITY for use of CITY right-of-way as shown in Exhibit A for the specific uses cited herein and in Exhibit A.

2. UNIVERSITY accepts and shall comply with the terms set forth by CITY engineers namely: UNIVERSITY shall cause conduit to be pushed under existing CITY pavements leaving said pavements undisturbed and excavation to install cables shall be replaced by UNIVERSITY equivalent to existing conditions.

3. UNIVERSITY shall do the following:

- A. All conduit placed under the terms of this Agreement shall be not less than one (1) foot beneath existing pavements;
- B. All cable shall be not less than thirty (30) inches beneath existing surface grade levels;
- C. Where cable is installed under the terms of this Agreement it shall be approximately two (2) feet north of the south alley line as shown in Exhibit A;



- D. The UNIVERSITY shall notify Northern Illinois Water Company, Illinois Power Company, Illinois Bell Telephone Company and the Urbana City Electrician before any cables or conduits are installed under the terms of this Agreement;
- E. UNIVERSITY shall notify the City Engineer not less than twenty-four (24) hours prior to excavating for the placement of cables and conduit according to this Agreement;
- F. All traffic control devices used during construction under this Agreement shall conform to the applicable provisions of the current edition of the Illinois Manual of Uniform Traffic Control Devices for Streets and Highways.

4. UNIVERSITY shall be responsible for all expenses incurred as a consequence of installing the cables and conduits shown in Exhibit A.

5. UNIVERSITY shall be responsible for the expenses incurred for any relocations of or repairs to the cables and conduits shown in Exhibit A which such relocation shall be undertaken by UNIVERSITY at any time so requested by CITY.


6. Upon UNIVERSITY ceasing to use CITY right-of-way for the specific purposes shown in Exhibit A the right-of-way shall revert back to CITY.

7. UNIVERSITY will be responsible for providing CITY with evidence of a liability insurance policy insuring CITY in an amount of not less than \$1,000,000 per occurrence said policy to be in force during the period of construction.
