## DEDICATION OF RIGHT-OF-WAY FOR PUBLIC ROAD PURPOSES

THIS INDENTURE WITNESSETH, That the Grantors, THE HARRY GILL COMPANY and APL ENGINEERED MATERIALS, INC. of the County of Champaign and State of Illinois, in accordance with the Annexation Agreement approved on March 6, 1989 by the Urbana City Council under Ordinance No. 8889-63 and the benefits resulting from the maintenance of the public highway herein referred to as Beeson Drive and Beeson Drive Extended do by these presents, hereby grant, convey and dedicate to the People of said City of Urbana for the purpose of a public highway, a tract of land situated in the County of Champaign and State of Illinois, described as follows:

The North 30 feet of the South Half of the Northeast Quarter of Section 5, Township 19 North, Range 9 East of the Third Principal Meridian, situated in Cunningham Township, Champaign, Illinois, encompassing 1.82 acres, more or less.

And the Grantors further, as a part of this dedication, agree to remove any and all fences (with the exception of Hedge Fences), enclosures, buildings and other obstructions from the above-described tract, and to completely vacate the same within fifteen (15) days after the date of this instrument, and the City of Urbana and its representatives, engineers, agents, contractors and employees are hereby authorized to enter into and take full and complete possession of said tract, and any fences (with the

exception of Hedge Fences), enclosures, buildings or other obstructions remaining thereon, after the expiration of said fifteen (15) days, may be removed by them or any one of them, and the expense thereof the said Grantors agree to pay upon demand.
